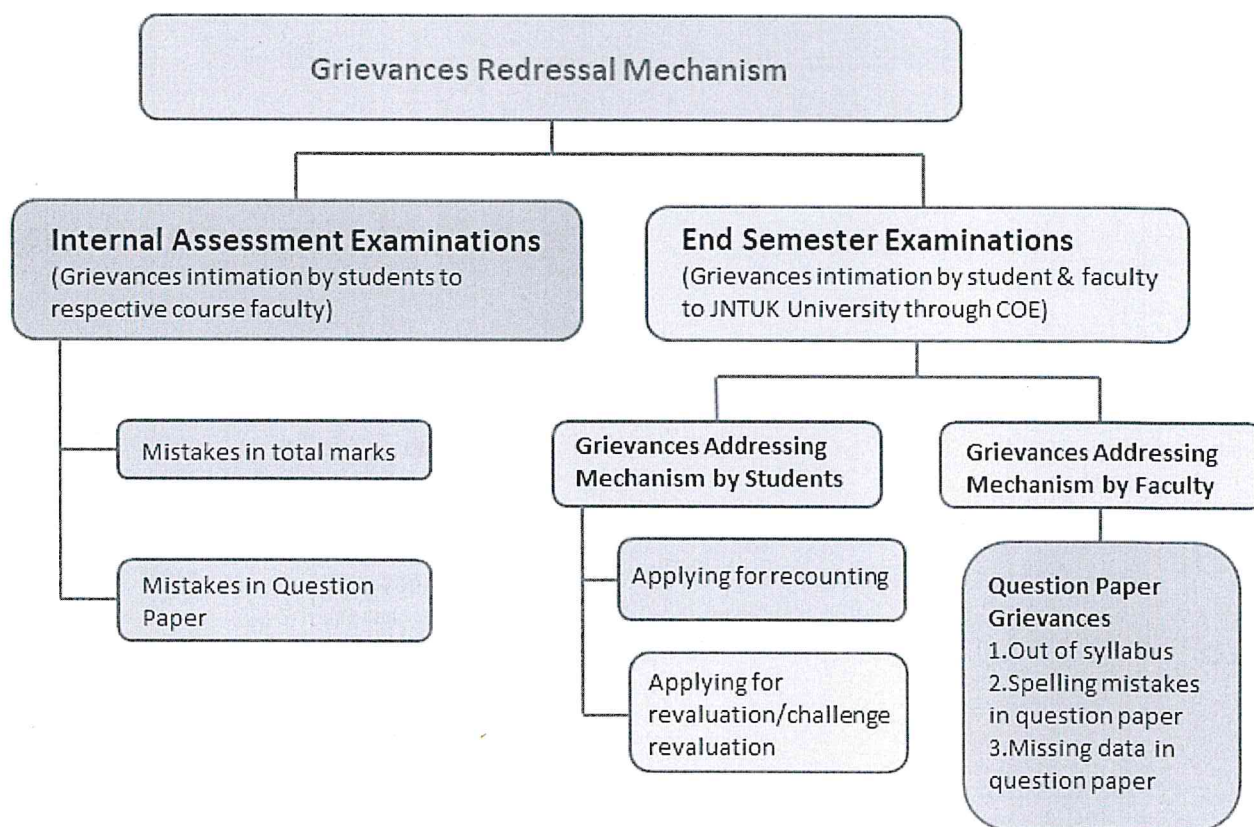




1. Mechanism to deal with internal examination related Grievances:
