GREENCAMPUSINITIATIVES

Aditya College of Pharmacy is an extensive green pastured land which is committed to create environment consciousness among its members and in the society. The college campus includes green spaces embellished with several native and nonnative tree species, fruit trees, flowering and decorating plants and trees and plants of medicinal value. It offers the opportunity to take the lead in redefining the environmental culture and developing new paradigms by creating sustainable solutions to environmental, social and economic needs promoting as stress-free learning environment on the campus. The bio-diversity across campus not only ensures a noise free campus off the main arterial road outside, but also maintain cool environment inside the college premises. Though implementing green initiatives are challenging and require determination and a long-term commitment, our college is taking initiatives in the right direction.

The following practices are undertaken by the college:

1. Restricted entry of automobiles

To prevent huge vehicles from accidentally entering the campus, our institution establishes a restriction on automobile admission. Our college has a group of buses to transport many students from different places in suburban areas. This initiative helps in reducing pollution and consumption of petrol. The college encourages the staff and students to use the college transport by providing them fleet of buses which operates from each and every corner of east and west Godavari district. Instead of using their own vehicles students and staffs can use college transport for reducing environmental pollution, fuel conservation, safety and security. All the college buses are certified by the authorized agencies after conducting the pollution check. The validation and periodicity of the certificate is randomly checked from time to time. Parking space for vehicles is provided at the main entrance and at various places inside the campus. Unauthorized vehicles are restricted for entry at the main gate of the college campus.

2. Battery-powered vehicles

College also provides battery operated vehicles inside the campus for students, staffs and visitors to keep a check on air pollution and sound pollution.

3. Pedestrian-friendly pathways
