iii. Fund shall be utilized only for the purpose for which it is being released



In accordance with the Rule 230 (8) of GFR 2017 , all interests or other earnings against Grants in aid or advances (other than reimbursement) released should be mandatorily remitted to the Consolidated Fund of India immediately after finalization of the accounts through Non-Tax Receipt Portal (NTRP)

vii. Any deviation/non-compliance of instructions/guidelines shall affect the further distribution of Funds.
