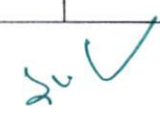

In the reference 1st cited, Government have issued detailed Instructions for Post-Matric scholarships which includes the administration of scholarships and the procedure for scholarships.

2. In the reference 2nd cited, Government of Telangana have issued orders that Post Matric Scholarship Scheme shall be continued for the academic year 2014-15 vide instructions issued earlier, subject to the condition that scholarship shall be made available only to the local students of Telangana envisaged under the presidential order. The students shall furnish the details of educational records of the last seven consecutive years ending with the year of the qualifying examination for the course of study.

3. Government have notified fee Structure for Under Graduate and Post graduate Courses i.e. B.E./B.Tech, B.Architecture and other related Courses, B.Pharmacy, Pharma-D and MCA, MBA, ME/ M.Tech, M.Pharmacy, Pharma.D(PB) and M.Arch, M. Planning courses in Private Un-Aided Institutions in the State, for the block period 2016-17 to 2018-2019 vide in the reference 3rd & 4th cited.

4. In the reference 5th cited, Government issued orders to continue the existing quantum of Reimbursement of Tuition Fee(RTF) being reimbursed for UG and PG course as per the orders issued earlier for the Block Period 2016-17, 2017-18 and 2018-19.

5. In the reference 6th cited, the Secretary, State Council of Higher Education, Hyderabad has informed that the Admissions Counselling activity through various TSCETs are scheduled to commence from 1st week of May 2018 for the AY 2018-19 and requested to issue necessary orders for continuance of Reimbursement of Tuition Fee for the students admitted through various TSCETs during Academic Year 2018-19.

6. In view of the above, Government have permitted the EAMCET Convenor-2018, to be made following endorsement on the allotment letters for successful candidates during the counseling's process, regarding quantum of fee reimbursement for all the eligible local students of Telangana envisaged under the Presidential order, who admitted through EAMCET-2018 under convener quota in to the Under Graduate Engineering Courses including B.Arch courses for the Academic year 2018-19 subject to verification for the year 2018-19.

A. Fee Reimbursement shall be given for all eligible students who are local to Telangana as per the Presidential orders and vide G.O Ms. No.66, SW (Edn.2)Dept., Dated. 08.09.2010, subject to the following categories:-

- i. All SC / ST/MW students of Telangana shall be given full fees reimbursement.
- ii. All Students other than SC/ST/MW, who have studied in Government & Residential Colleges run by the welfare and Education departments including students sponsored by the Government under the corporate college scheme (G.O MS.No.235, SW(Edn.2) Dated. 28.03.2011) shall be eligible for full fees reimbursement.

- iii. All students other than SC/ST/MW, who have obtained an EAMCET rank up to 10,000 (Ten thousand rank only) shall be eligible for full fee reimbursement.
- B. All students other than i, ii, iii above, shall be eligible for reimbursement up to maximum of Rs. 35,000/- or the actual fee, whichever is less regardless of the fee charged by the college.
7. The Convener of EAMCET-2018 entrance examination shall ensure that the above endorsement is made in all allotment letters where candidates are found eligible for a scholarship.

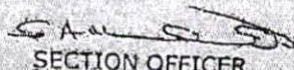
