ORDER:-

The A.P. Higher Education Regulatory and Monitoring Commission (APHERMC), in its meeting held on 15.12.2020, 17.12.2020, 18.12.2020 and 19.12.2020 has resolved to determine the fee structure for B.Tech., B.Arch. and Marine Engineering courses for the block period 2020-21 to 2022-23 in respect of Private Un-Aided Professional Institutions in the State of Andhra Pradesh.

- 2. The Secretary, A.P. Higher Education Regulatory and Monitoring Commission in his letter 2nd read above has furnished the Minutes of the Meeting of A.P. Higher Education Regulatory and Monitoring Commission held on 19.12.2020 along with the recommendations regarding the fee structure for B.Tech., B.Arch. and Marine Engineering for the block period 2020-21 to 2022-23 in respect of Private Un-Aided Professional Institutions in the State of Andhra Pradesh and requested to issue necessary Notification in the matter.
- Government after careful examination of the matter, hereby issue the following Notification which shall be published in the Andhra Pradesh Extra-Ordinary Gazette:-

NOTIFICATION

- 4. In exercise of the powers conferred under Rule 8 of the A.P. Higher Education Regulatory and Monitoring Commission Rules, 2019 issued in G.O.Ms.No.49, Higher Education (UE) Department, dated 11.10.2019 as amended subsequently from time to time and in pursuance of the resolutions of the A.P. Higher Education Regulatory and Monitoring Commission in their Meeting held on 19.12.2020, the Commission recommended the fee structure for Private Un-Aided Professional Institutions offering B.Tech., B.Arch. and Marine Engineering in the State of Andhra Pradesh.
- 5. Further, in exercise of the powers conferred under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No.5 of 1983), Government hereby notify the Fee as mentioned in the Annexures appended to this Order for the block period 2020-21 to 2022-23, subject to following directions:
 - a. The fee is an all-inclusive annual fee, including like tuition fee, affiliation fee, cost of identity card, medical fee, inter college/inter university sports, games & cultural meet fee, computer/internet fee, College magazine and student activities, student health care scheme, student welfare fund, study tour, alumni fund, sports and games fee, examination fee including stationery, maintenance and amenities fee, extracurricular activities fee, development fee, Recognition fee, Common Services fee and other recurring expenditure;

- b. The same fee shall continue for the students admitted during the block period of 2020-21 to 2022-23 till they complete the course;
- c. The institutions whose affiliations are not extended by the affiliating Universities for the academic year 2020-21 are not entitled to collect any fee;
- d. The institution shall not charge either directly or indirectly any other amount over and above the fee fixed in the ANNEXURE-I(B.Tech), ANNEXURE-II (B.Arch)and ANNEXURE-III (Marine Engineering). If any other amount is charged under any other head or guise i.e., donations, etc. the same would amount to charging of capitation fee and in that case the institution shall be liable to be prosecuted under Section 9 of Andhra Pradesh Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983 (Act No. 5 of 1983) apart from imposing appropriate penalty under the APHERMC Act, 2019 and the APHERMC Rules, 2019 as amended subsequently from time to time;
- In case of any deviation from these directions, the Commission will initiate serious penal action as per the provisions of the Act and Rules made there under;
- f. Under Section 12 (4) & (5) of A.P. Higher Education Regulatory and Monitoring Commission (Amendment) Act, 2020, the Commission has the power to review and determine the fee payable to the Higher Educational Institutions and review the fee determined, whether notified or not by the Government for any academic years / blocks; and
- g. The institutions are informed that the fixation of Fee structure by the Government will not by itself enable or permit the managements to run courses, if the courses are not recognized / permitted by the Government / All India Council for Technical Education / concerned University / any other statutory Authority.

Higher Education Regulatory and Monitoring Commission held on 17.03.2020 along with the recommendations regarding the fee structure for B.Tech., for the year 2019-20 in respect of Private Un-Aided Professional Institutions in the State of Andhra Pradesh and requested to issue necessary Notification in the matter.
- Government after careful examination of the matter, hereby issue the following Notification which shall be published in the Andhra Pradesh Extra-Ordinary Gazette:-

NOTIFICATION

4. In exercise of the powers conferred under Rule 8 of the A.P. Higher Education Regulatory and Monitoring Commission Rules, 2019 issued in G.O.Ms.No.49, Higher Education (UE) Department, dated 11.10.2019 and in pursuance of the resolutions of the A.P. Higher Education Regulatory and Monitoring Commission (APHERMC), in their Meeting held on 17.03.2020, the Commission recommended the fee structure for Private Un-Aided Professional Institutions offering B.Tech. courses in the State of Andhra Pradesh.

- 5. Accordingly, the Government of Andhra Pradesh hereby notify the following Tuition Fee and special fee structure for Graduate Engineering (B.Tech.) courses in Private Un-Aided Professional Institutes In the State of Andhra Pradesh for the year 2019-20:-
 - 1) The fee structure for (282) Private Un-Aided Professional Institutions offering B.Tech. courses in the State of Andhra Pradesh is appended as Annexure to this order.
 - 2) The Private Un-Aided Engineering Colleges are permitted to collect:
 - a) An amount of Rs.2000/- as one time payment per student at the time of admission towards Admission/Registration/Recognition fees and out of the said amount of Rs.2000/-, Rs.500/- shall be remitted by the institution to the concerned University and the remaining amount of Rs.1500/- shall be retained by the institution for meeting different administrative expenditures.
 - b) An amount of Rs. 1,850/- per annum per student towards common services rendered by the University to the College as mentioned below and such amount collected by the College shall be remitted to the concerned University.

- c) An amount of Rs.500/- towards library deposit and an amount of Rs.500/- towards laboratory deposit (totaling into Rs.1000/-) by way of refundable caution deposits at the time of admissions only as one time payment.
- 6) The following directions are given to the Private Un-aided Under-Graduate Engineering (B.Tech) Institutions:
 - a) The institutions shall not charge any capitation fee or any amount unauthorizedly or illegally under any other head or guise either directly or indirectly, other than the fee notified by the Government, as collection of any such unauthorized amounts would amount to charging of Capitation Fee. The surplus (profit) that is generated from the collection of the Fee must be for the benefit of the institutions and cannot be diverted for other purposes or for personal gain.

- b) The institutions are informed that the fixation of Fee Structure by the Government will not by itself enable or permit the managements to run courses, if the courses are not recognized/permitted by the Government / All India Council for Technical Education / Concerned University/ any other statutory Authority.
- c) The fee, now recommended by the A.P. Higher Education Regulatory and Monitoring Commission (APHERMC) for the year 2019-20, is based on the details/figures uploaded by the institutions online and the submissions made by the representatives of the respective institutions during the personal hearing and evaluation of reports / worksheets of the Auditors. If it is found that any of the data given by the institutions is not correct, the fee shall be revised at a later date and these facts shall be informed to the University concerned, All India Council for Technical Education and other Regulatory Authorities for taking necessary action in accordance with law. Besides, such institutions/colleges including the persons responsible are also liable for penal consequences.

The A.P.Admission and Fee Regulatory Committee, in its meeting held on 27-05-2016, has resolved to fix the fee structure for B.E. / B.Tech courses for the block period 2016-17 to 2018-19 in respect of Private Un-Aided Professional Institutions in the State of Andhra Pradesh, as contemplated in Rule 4(v) of the A.F.R.C. Rules issued in GOMs.No.6, Higher Education(EC.A2)Department, dt.08-01-2007.

- 2. The Administrative Officer, O/o A.P.Admission and Fee Regulatory Committee, Hyderabad, in his letter 2nd read above, has furnished the Minutes of the Meeting of A.P.Admission and Fee Regulatory Committee held on 27-05-2016 along with the recommendations of the AFRC regarding the fee structure for B.E. / B.Tech for the block period 2016-17 to 2018-19 in respect of Private Un-Aided Professional Institutions in the State of Andhra Pradesh and requested to issue necessary notification in the matter.
- After careful examination of the matter, the Government hereby issue the following notification and shall be published in the Andhra Pradesh extra-ordinary Gazettee:-

NOTIFICATION

In exercise of the powers conferred under rule 8 and 9 of the Andhra Pradesh Unaided Minority / Non-Minority Professional Institutions (Regulations of Admissions into Under-Graduate and Pharm-D (Doctor of Pharmacy) Professional Courses through Common Entrance Test) Rules, 2011 issued in the G.O.Ms.No.74, Higher Education(EC.2)Department, dt.28-07-2011, G.O.Ms.No.75, Higher Education(EC.2)Department, dt.28-07-2011 and G.O.Ms.No.60, Higher Education(EC.2)Department, dt.26-05-2006, read with sub rule (v) of Rule 4 of A.P.Admission and Fee Regulatory Committee (For Professional courses offered in Private Un-aided Professional Institutions) Rules, 2006 issued in G.O.Ms.No.6, Higher Education(Ec.2)Department, dt.08-01-2007 and in pursuance of the resolutions of the Committee(AFRC) in their meeting held on 27-05-2016, the Governor of Andhra Pradesh hereby notify the following fee and special fee structure for Under-Graduate Engineering courses in Private Unaided Professional Institutes in the State of Andhra Pradesh for the academic years 2016-17, 2017-18 and 2018-19:-

- The fee structure to (273) Private Un-Aided Professional Institutions offering B.E. / B.Tech courses in the State of Andhra Pradesh is appended as Annexure to this order.
- 2) The Private Un-Aided Engineering Colleges are permitted to collect:
 - a) An amount of Rs. 2,000/- as onetime payment per student at the time of admission towards Admission/Registration/Recognition fees and out of the said amount of Rs. 2,000/-, Rs. 500/- shall be remitted by the institution to the concerned University and the remaining amount of Rs. 1,500/- shall be retained by the institution.

- b) An amount of Rs. 1,850/- per annum per student during the course towards common services rendered by the University to the college as mentioned below and such amount collected by the College shall be remitted to the concerned University.
- c) Particulars of the amounts that can be collected towards common services rendered by the University to the College are:-

- d) An amount of Rs. 500/- towards library deposit and an amount of Rs. 500/- towards laboratory deposit (totaling into Rs. 1000/-) by way of refundable caution deposits at the time of admission only as one-time payment.
- 3) The following directions are also given to the concerned Private Under-Graduate Engineering Institutions:
 - a) The institutions/colleges shall collect the Annual Tuition Fee every year in advance only for that particular year either in a lump sum or in installments, if it so opts.
 - b) The institutions shall not charge any capitation fee or any amount unauthorisedly or illegally under any other head or guise (e.g., donation etc.), either directly or indirectly, other than the fee fixed by the Committee, as collection of any such unauthorized amounts would amount to charging of Capitation Fee, and that the surplus (profit) that is generated from the collection of the Fee must be for the benefit of the institutions, and cannot be diverted for other purposes or for personal gain.
 - c) The institutions are informed that the fixation of Fee Structure by the Committee will not by itself enable or permit the managements to run the relevant courses in their institutions because, if the courses are otherwise not recognized and not permitted by the Government or All India Council for Technical Education/Concerned University at any relevant time, the same cannot be done.
 - d) The fee, now recommended by the AFRC for the block period 2016-17 to 2018-19, is based on the details/figures uploaded by the institutions on line and is subject to further physical verification. If it is found that any of the data given by the institutions is not correct, the fee shall be revised at a later date and these facts shall be informed to the University concerned and All India Council for Technical Education for taking necessary action in accordance with law. Besides, such institutions/ colleges including the persons responsible are also liable for penal consequences.
