Staff is sensitized on the following aspects related to code of conduct of the institute by the principal:


- All the teaching staff should maintain dignity with respective of their position.

Students are sensitized on the following aspects related to code of conduct of the institute by the principal:


- Students should adhere to the rules and regulations of the college and maintain harmony.
