She displayed the statistics how the crime rate is increasing year by year against woman. She educated the fundamental rights of women in India to the participants. She created awareness on different acts available to safeguard women with real-time examples i.e., **Dowry Prohibition Act 1961, Immoral Traffic (Prevention) Act 1956, Prohibition of Child Marriage Act 2006, Protection of Women from Domestic Violence Act 2005 etc.** She also mentioned different provisions related to offences against women in Indian Penal Code 1860 **Section 498-A: Cruelty to a women within the matrimonial home, Section 375 IPC: Deals with the offence of Rape etc.** She stressed on some of the IPC Sections related to **Voyeurism, Stalking, Sexual harassment.** She suggested students concentrate on their studies to have bright future. She deliberated few suggestions on how the students can build their career.

Along with the chief guest, Circle Inspector, Jaggampet division, Mr.S Laxman Rao and Bar council members visited the campus and interacted with the students.




Feedback from students:

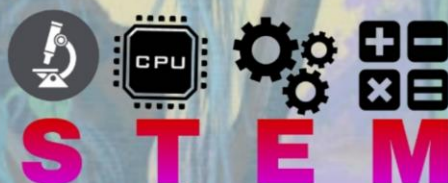

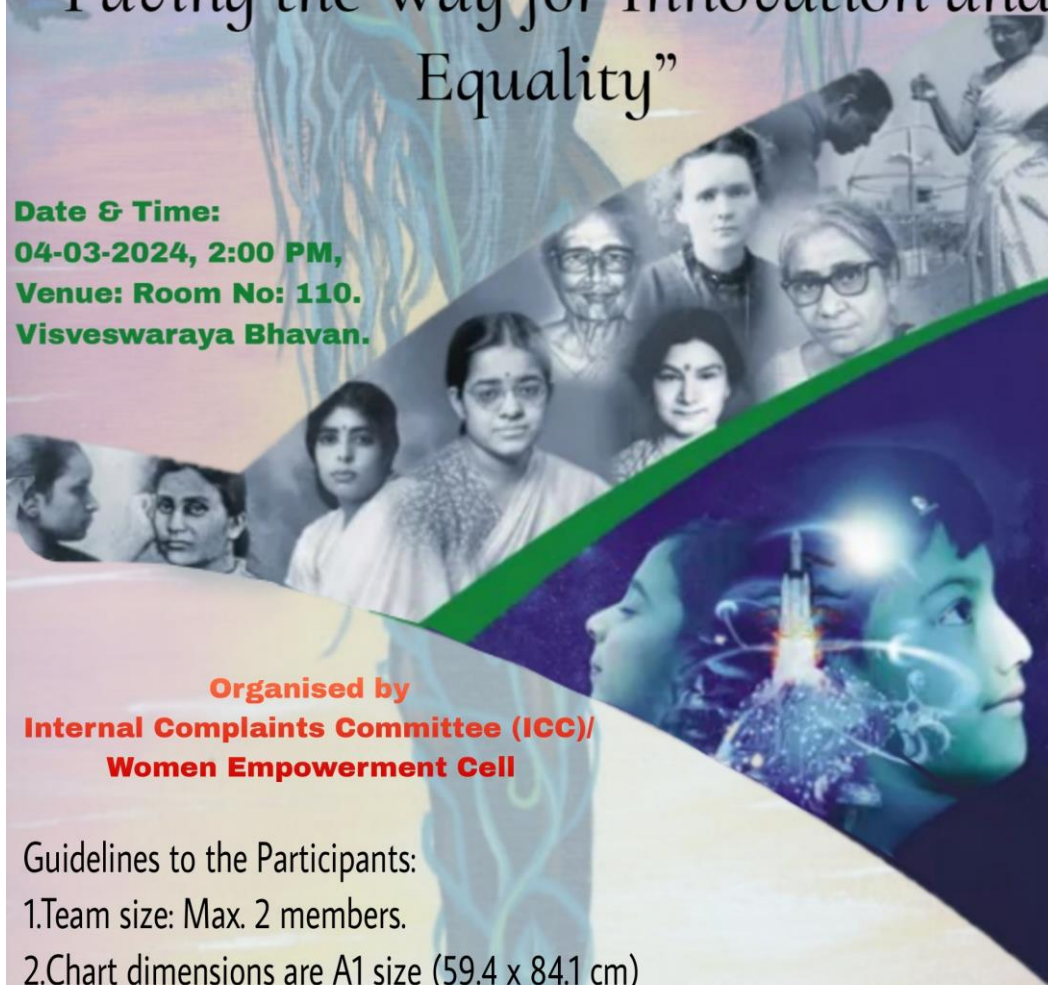

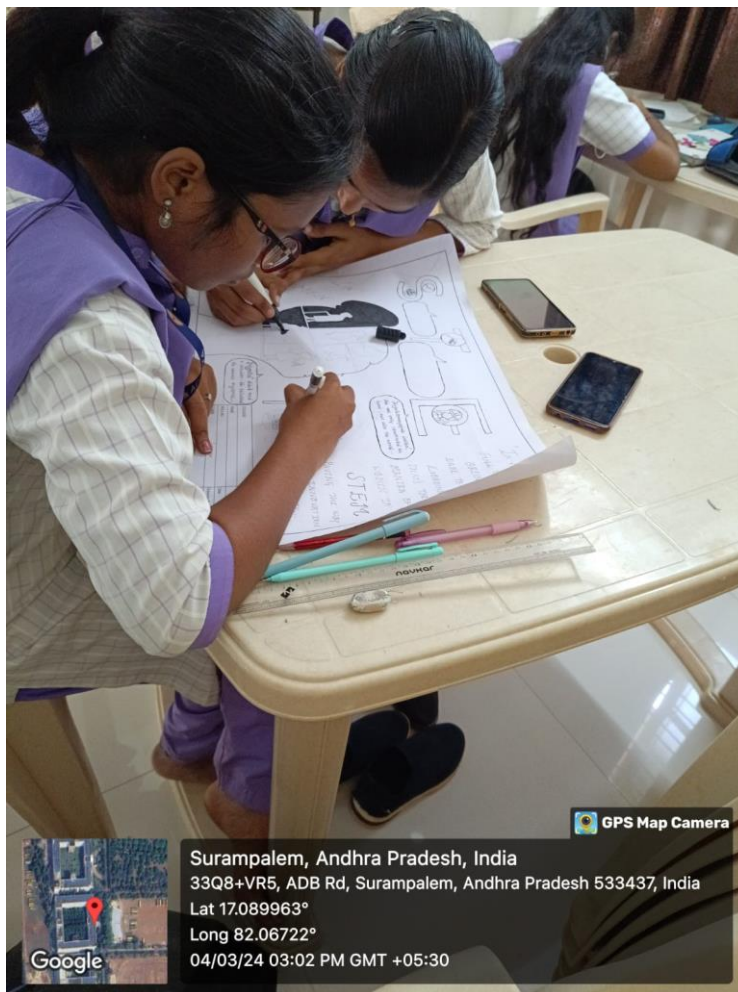
