The meeting of IQAC was commenced with the welcome note by the Coordinator-IQAC. The Coordinator presented the agenda and requested the Chairman-IQAC to start the meeting based on the points of agenda for discussion and the resolutions made are presented here.

The Chairman-IQAC welcomed all the members to the meeting and discussed the points of the agenda.

#### MINUTES AND RESOLUTIONS

- 1) The Chairman reviewed the points of agenda discussed in earlier meetings and further, he said that all the activities related to agenda points will be discussed later and notified the members the following information:
  - a) Chairman said that this information is conveyed in HoDs meeting and again being conveyed in IQAC meeting: UGC modified and released a new Gazette dated 03<sup>rd</sup> April 2023 stating the eligibility conditions that any college having NAAC accreditation or NBA accreditation for three programmes with a validity of one year is eligible to apply for Autonomous status. Therefore, the same is submitted to Governing Body (GB), proposed and permitted by GB to apply for autonomous status from AY 2023-24.
  - b) Our college applied to UGC for Autonomous status with all the required documents along with specified amount and submitted on 19th June 2023 and awaiting for conferment of Autonomous status.
  - c) If autonomous status is conferred by the UGC then members are required and the Chairman of GB suggested two names as members of the Governing Body (GB) as society nominees. The details are of two nominees are:

- d) After conferment of autonomous status, Finance committee, Academic Council and Boards of Studies (BoS) are to be formed with University nominees and eminent people from academia and industry. GB is also to be reframed as per the guidelines of UGC.
- e) Curriculum for UG/PG programmes is to be prepared and syllabi for all the courses along with assessment is to be decided with permission from affiliating university, JNTUK.
- f) Meetings of BoS, Academic council and GB are to be conducted and ratification of the curriculum, regulations, course structure along with syllabi should get ratified.
- g) IIQA of NAAC Cycle 2 was submitted to NAAC on 31st March 2023 with the specified amount and got the approval. Self Study Report (SSR) already submitted on 01.07.2023.
- h) AQAR 2021-22 is to be submitted and the date is extended by NAAC till 31st July 2023 and AQAR should be submitted positively before the deadline.
- Chairman advised IQAC Coordinator to check the guidelines of UGC for all the committees and advised all the members to suggest names of eminent people for the same.
- 2) Chairman advised the members to carry out all the activities as usual and review of remaining agenda points will be discussed in the next meeting and advised IQAC Coordinator to conduct IQAC meeting during November/December 2023.

The Chairman advised all the members to focus on academic matters both theory and laboratory sessions and obtain best results by giving proper inputs to students and further added counselling/proctoring should be carried out periodically to improve further.

Finally, the Coordinator and the Chairman thanked all the members present and appreciated their effort and commitment exhibited towards accreditation process and anticipated the same in future also.
