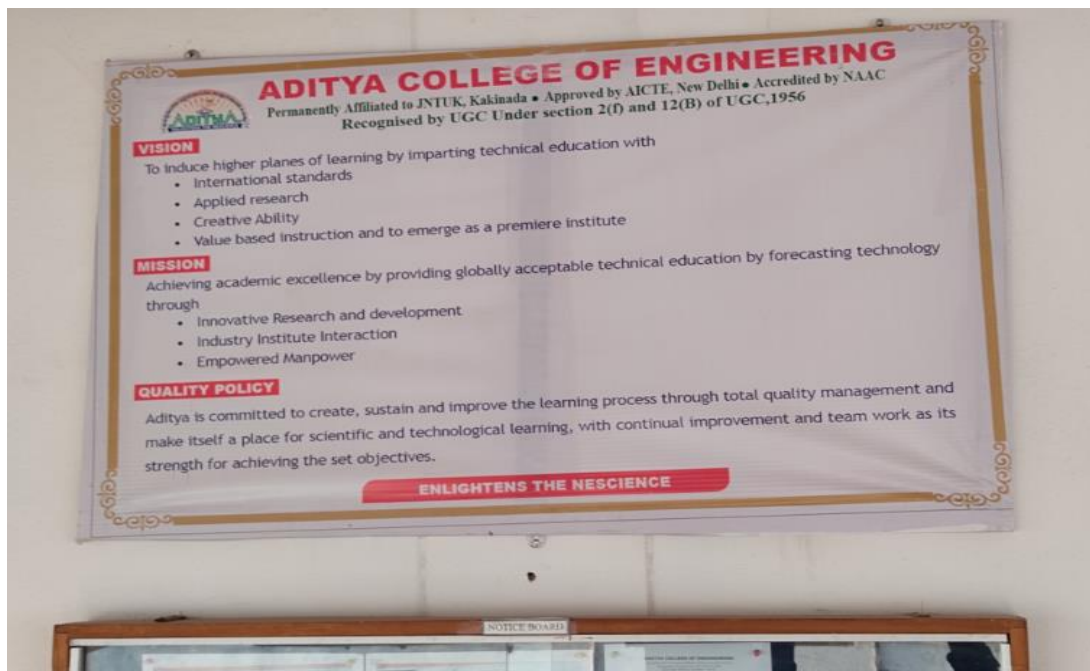

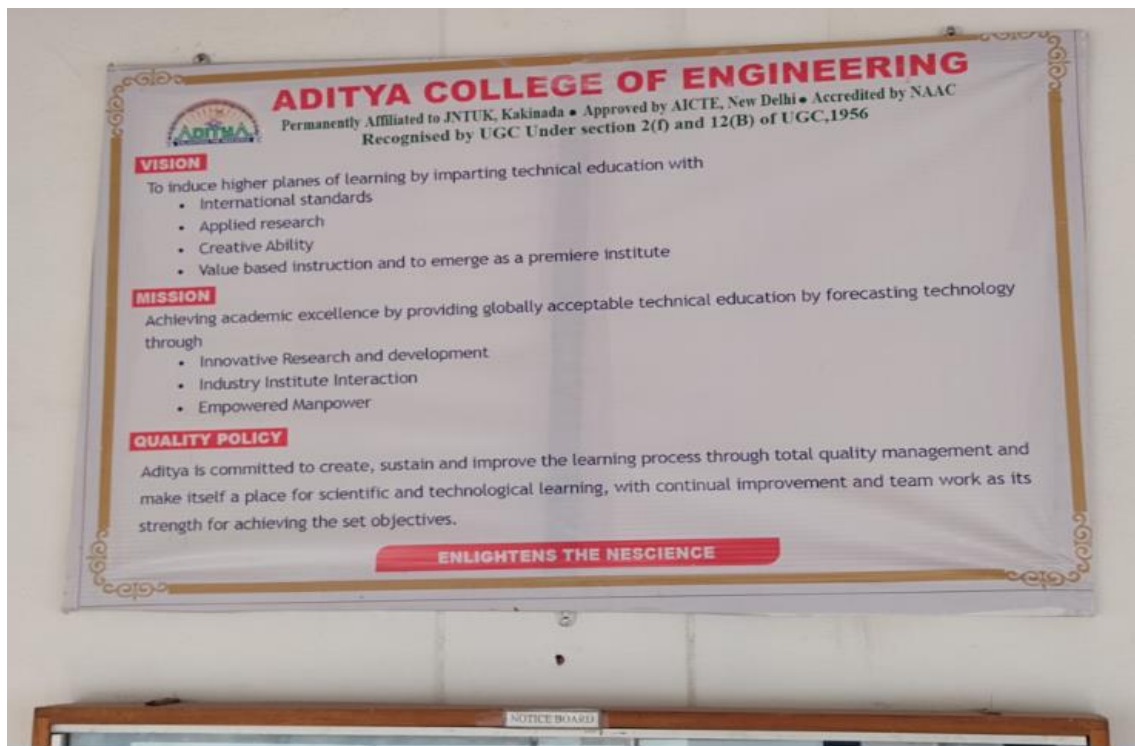
### Vision and Mission at Administrative office
